**Tuition and Family Commitment Agreement**  
**Multiple Student Scholarship Assistance 2010-2011**

**THIS FORM IS FOR FAMILIES REGISTERING DURING MARCH 2010 WHO HAVE 2 OR MORE STUDENTS AND DESIRE TO TAKE ADVANTAGE OF THE MULTIPLE STUDENT SCHOLARSHIP ASSISTANCE PLAN. PARTICIPATING PARENT SERVICE HOURS PERFORMED BETWEEN MAY 1, 2010 AND APRIL 30, 2011 ARE REQUIRED TO EARN THIS SCHOLARSHIP. (30 hours for one student receiving scholarship assistance or 50 hours for two or more students receiving scholarship assistance)**

**NOTE: The Family Registration Form listing your student(s) and grade(s) must accompany this signed agreement.**

***The deadline for returning families to enroll in this plan is March 31, 2010.***

New families who register after March 31, 2010 may apply at that time.

I/we commit to paying tuition per student based on the following chart and to complete the required Participating Parent Service Hours.

First student	\$3695	(zero discount for first student)
Second Student	\$3595	(\$100 discount)
Third Student	\$3395	(\$300 discount)
Fourth Student plus	\$3195	(\$500 discount)

Please check the payment plan you agree to follow:

\_\_\_\_\_ I/we agree to make one payment on or before August 12, 2010 to pay all tuition due.

\_\_\_\_\_ I/we agree to make two equal payments; one no later than August 12, 2010 and the second no later than February 1, 2011 to pay all tuition due.

\_\_\_\_\_ I/we agree to make \_\_\_\_\_ (10 or 11) monthly payments beginning no later than July 20, 2010 for 11 payments or August 20, 2010 for ten payments and ending no later than May 20, 2011, to pay all tuition due. ***This option requires the use of the F.A.C.T.S. program (automatic withdrawal from a checking or savings account) unless arrangements are made in advance with the Director of Corporations. There is an additional \$35 annual fee paid to F.A.C.T.S. This fee is added to your first withdrawal. NOTE: A F.A.C.T.S. application will be mailed to you based on the number of months indicated. This application must be returned to the school office no later than June 1, 2010.***

***I/we have already paid or enclosed \$100.00 per student as a NON-REFUNDABLE registration fee with this commitment to SCCS. This registration fee will only be applied to tuition if paid by March 31, 2010.***

**SCRIP Requirement: (check one option)**

\_\_\_\_\_ \$225 in direct tuition per family which will be added to total tuition due above.
