

**St. Croix Catholic School**

**Tuition and Family Commitment Agreement – Multiple Student Scholarship Plan 2011-2012**

Participating Parent Service Hours performed between MAY 1, 2011 AND APRIL 30, 2012 ARE REQUIRED to earn this scholarship; 30 hours for one student receiving scholarship assistance or 50 hours for two or more students receiving scholarship assistance. For example if you have two children at SCCs and are using this plan, you will be expected to give 30 hours. If you have three or more children at SCCS, you will be expected to give 50 hours. The deadline for returning SCCS families to enroll in this scholarship plan is March 31, 2011. Families new to the school may apply when they register.

I/we commit to paying tuition per student based on the following chart and to complete the required Participating Parent Service Hours.

Second Student	\$3395	(\$300 discount)	Fourth Student	\$2515 (\$1180 discount)
Third Student	\$3395	(\$300 discount)	Fifth and up	\$000 (Family Max \$13,000)

Please check the payment plan you agree to follow:

\_\_\_\_\_ I/we agree to make one payment on or before August 15, 2011 to pay all tuition due.

\_\_\_\_\_ I/we agree to make two equal payments; one no later than August 15, 2011 and the second no later than February 15, 2012 to pay all tuition due.

\_\_\_\_\_ I/we agree to make 10 equal monthly payments beginning no later than August 15, 2011 and ending no later than May 15, 2012, to pay all tuition due. This option requires the use of automated, prescheduled payments using electronic funds transfer from a checking or savings account; unless arrangements are made in advance with the Director of Corporations.

\_\_\_\_\_ I/we agree to make 11 equal monthly payments beginning no later than July 15, 2011 and ending no later than May 15, 2012, to pay all tuition due. This option requires the use of automated, prescheduled payments using electronic funds transfer from a checking or savings account; unless arrangements are made in advance with the Director of Corporations.

**SCRIP Requirement:**

Every family must generate \$225 in total SCRIP earned revenue (approximately \$7,800 in gross purchases) or pay \$225 in direct tuition. Earned revenue accumulates between May 1, 2011 and April 30, 2012.

I/we have enclosed (or already paid) \$100.00 per student as a NON-REFUNDABLE registration fee with this commitment to SCCS. This registration fee will be applied to tuition if paid by March 31, 2011. It is Non-Refundable.

I/we have read and understand the tuition and payment options detailed on the Tuition and Scholarship Assistance Overview for 2011-2012. I/we understand that joining the St. Croix Catholic School community carries with it the expectation that I/we will fulfill our family Marathon goal, participate in other fund raising efforts and be active members of the school and Tri-Parish community.
